<p><b>Duitse Dog (RSI-ras) ***</b> 20.12.2012/EN FCI-Standard N° 235 Rasgroep II</p>	<p>LIPS: Well defined corners of lips. Lips neither lacking flews nor being too pendulous or rolled in.</p>
	<p>EYES: Of medium size with lively friendly intelligent expression. Almond shaped with close fitting lids. Eyes not set too wide apart or slit eyes.</p> <p>FAULTS: Eyes protruding or too deeply set. Carpus bent, enlarged, or knuckling over. Pasterns which are markedly weak, too sloping or too upright. Hindquarters with too much or too little angulations. Hock joints that are open, enlarged or unstable. Cow hocked as well as rear pasterns too close together. Dewclaws. Feet splayed or long.</p> <p>SEVERE FAULTS: Slack eye lids and showing red haw.</p> <p>DISQUALIFYING FAULTS: Fear-biting, easily provoked. Ectropion, entropion or macroblepharia. Deafness.</p>
<p><b>Engelse Bulldog (RSI-ras) *</b> 10.01.2011/EN FCI-Standard N° 149 Rasgroep II</p>	<p>GENERAL APPEARANCE: Face <b>relatively</b> short, muzzle broad, blunt and inclined <b>slightly</b> upwards, <b>although not excessively so.</b></p>
	<p>BODY <b>fairly</b> short, well knit, limbs stout, well muscled and in hard condition <b>with no tendency towards obesity.</b></p> <p>HEAD Viewed from side, head appears very high and <b>moderately</b> short from back to point of nose. Forehead flat with skin on and about head, <b>slightly loose</b> and finely wrinkled <b>without excess</b>, neither prominent nor overhanging face. Face from front of cheek bone to nose, <b>relatively</b> short, skin <b>may be slightly</b> wrinkled. Distance from inner corner of eye (or from centre of stop between eyes) to extreme tip of nose <b>should not be less than the distance</b> from tip of <b>the</b> nose to edge of <b>the</b> underlip.</p> <p>SKULL: Skull <b>relatively</b> large in circumference.</p> <p>MUZZLE: Muzzle short, broad, turned upwards and deep from corner of eye to corner of mouth. <b>Over nose wrinkle, if present, whole or broken, must never adversely affect or obscure eyes or nose. Pinched nostrils and heavy over nose wrinkle are unacceptable and should be heavily penalised.</b></p> <p>LIPS: Flews (chops) thick, broad and deep, <b>covering</b> lower jaws at sides, <b>but</b> joining underlip in front. <b>Teeth not visible.</b></p> <p>JAWS / Teeth: Jaws broad, <b>strong</b> and square, lower jaw <b>slightly</b> projecting in front of upper, with <b>moderate turn up</b></p> <p>NECK: Moderate in length, thick, deep and strong. Well-arched at back, with <b>some</b> loose, thick and wrinkled skin about throat, forming <b>slight</b> dewlap on each side.</p> <p><b>Lack of tail, inverted or extremely tight tails are undesirable.</b></p> <p>HINDQUARTERS: General appearance: Legs large and muscular, <b>slightly</b> longer in proportion than forelegs. Stifle (Knee): Stifles turned <b>very</b> slightly outwards away from body.</p>

<b>Mastiff (RSI-ras) *</b> 02.03.2011/EN FCI-Standard N° 264 Rasgroep II	SIZE is <b>desirable, but only</b> if combined with quality <b>and if absolute soundness is maintained.</b>
	<p><b>BEHAVIOUR AND TEMPERAMENT: Usually indifferent with strangers; timidity is unacceptable.</b></p> <p><b>MUZZLE: Whilst in repose, any exaggeration of wrinkle or excess of skin is unacceptable in mature adults.</b></p> <p><b>EYES: Moderate size,</b> wide apart. Colour hazel brown, darker the better, showing no haw. <b>Loose eyelids highly undesirable. Free from obvious eye problems.</b></p> <p><b>FOREQUARTERS: General appearance: Balanced and in harmony with hindquarters.</b></p> <p>Forefeet: Large, round and <b>tight.</b> Hind feet: Large, round and <b>tight.</b></p> <p><b>GAIT / MOVEMENT: Powerful, easy extension, driven from the rear, fluent, sound, with ground-covering strides. Level topline maintained whilst on the move. Tendency to pace is undesirable. Absolute soundness essential.</b></p>
<b>Mastino Napolitano (RSI-ras) ***</b> 17.12.2015/EN FCI-Standard N° 197 Rasgroep II	<b>EYES:</b> Set well apart on an equal frontal level; rather round in shape but never protruding or too deep set. Skin folds never to interfere with the eyes.
	<b>SKIN:</b> Never in abundance to the extent to interfere with the dogs health and wellbeing.
<b>Sharpei (RSI-ras) ***</b> 09.08.1999/EN FCI-Standard N° 309 Rasgroep II	<b>NOSE:</b> Large and wide, preferably black, but any colour conforming to general coat colour permissible. Wide opened nostrils.
	<p><b>JAWS/TEETH:</b> Padding of lower lip should not be so excessive as to interfere with the bite.</p> <p><b>EYES:</b> Function of eyeball or lid in no way disturbed by surrounding skin, folds or hair. Any sign of irritation of eyeball, conjunctiva or eyelids highly undesirable. Free from entropion.</p> <p><b>NECK:</b> The loose skin under the neck should not be excessive.</p> <p><b>BODY:</b> Folds of skin on body in mature dogs highly undesirable except on withers and base of tail, which show moderate wrinkling.</p> <p><b>TAIL:</b> Lack of or incomplete tail highly undesirable.</p> <p><b>HINDQUARTERS :</b> General appearance : Muscular, strong, moderately angulated.</p> <p><b>ELIMINATING FAULTS:</b> Lower lip rolled in, interfering with the bite. Round, bulging eye. Entropion, ectropion. Skin, folds or hair disturbing the normal function of the eye. Absence of tail; stumpy tail. Heavy folds of skin on body (except withers and base of tail) and limbs.</p> <p><b>REMARK :</b> Any artificial physical alteration to the Shar Pei (in particular lips and eyelids) eliminates the dog from competition.</p>

	EYES : Moderately deep set with a friendly expression. Natural tightness of lids desired. A small angular fold on the lower lids with the haws only slightly visible as well as a small fold on the upper lids are permitted.  FAULTS: Eyelids too loose. Crooked or severely turned out front legs. Poorly angulated, open-hocked or cow-hocked hindquarters. Faulty movement.  ELIMINATING FAULTS: Ectropion, entropion.

	FOREFEET: <b>Pads sound and free from cracks or horny excrescences.</b>  STIFLE (Knee): <b>Moderate turn.</b>
<b>Bull Terrier (RSI-ras) **</b> 23.12.2011/EN FCI-Standard N° 11 Rasgroep III	
<b>Foxterrier gladhaar *</b> 05.01.2011/EN FCI-Standard N° 12 Rasgroep III	EYES: Dark, <b>moderately</b> small, as near as possible circular in shape but <b>not prominent.</b>
<b>Manchester Terrier *</b> 10.01.2011/EN FCI-Standard N° 71 Rasgroep III	EYES: <b>Relatively</b> small.

<b>Skye Terrier *</b> 19.01.2011/EN FCI-Standard N° 75 Rasgroep III	COAT: Hair: Double. Undercoat short, close, soft and woolly. Outer coat of <b>reasonable length</b> , hard, straight, flat and free from curl, <b>never impeding action.</b> Hair on head shorter, softer, veiling forehead and eyes, <b>but not obscuring vision.</b>
<b>Welsh Terrier *</b> 19.01.2011/EN FCI-Standard N° 78 Rasgroep III	Eyes: <b>Relatively</b> small.
<b>West Highland White Terrier (RSI-ras) *</b> 12.01.2011/EN FCI-Standard N° 85 Rasgroep III	FOREQUARTERS: Shoulder-blades broad and lying close to chest wall. <b>Shoulder joint placed forward.</b> <b>Skin: Free from obvious skin problems.</b>
<b>Yorkshire Terrier (RSI-ras) *</b> 22.02.2012/EN FCI-Standard N° 86 Rasgroep IX	Hair: On body moderately long, perfectly straight (not wavy), glossy; fine silky texture, not woolly, <b>must never impede movement.</b>
	WEIGHT: Up to 3,2 kgs.
<b>Dashond (RSI-ras) *</b> 13.07.2001/EN FCI-Standard n°148 Rasgroep IV	MUZZLE : <b>Long, sufficiently broad and strong.</b>
	BACK : <b>Firm and well muscled.</b> Croup : <b>Broad and sufficiently long.</b> FRONT FEET : <b>Toes close together, well arched with strong, resistant, well cushioned pads and short strong nails. The fifth toe has no function but must not be removed.</b> HOCK JOINT : <b>Clean with strong tendons.</b>
<b>Chow Chow (RSI-ras) *</b> 27.01.2011/EN FCI-Standard N° 205 Rasgroep V	GENERAL APPEARANCE: <b>Should always be able to move freely and must not have so much coat as to impede activity or cause distress in hot weather. A bluish-black tongue is characteristic.</b>
<b>Dwergkeeshond (RSI-ras) *</b> 25.01.2013/EN FCI-Standard N° 97 Rasgroep V	DISQUALIFYING faults: Gap in fontanel. Ectropion or entropion.
<b>Basset Artésien Normand (RSI-ras) *</b> 14.04.1993/EN FCI-Standard N° 34 Rasgroep VI	FAULTS: FOREQUARTERS : • Shoulder straight, short, insufficiently muscled. • Out at elbows. • Pasterns touching each other, knuckling over. • Exaggerated crook with feet turning out excessively. • Flat feet. • Splay-feet.
<b>Bloedhond (RSI-ras) ***</b> 12.07.2002/EN FCI-Standard N° 84 rasgroep VI	GENERAL APPEARANCE: No characteristic should be so exaggerated as to destroy the harmony of the whole, to give an overdone appearance or even less to harm the health or well-being of the dog. Among possible exaggerations should be mentioned eyes which are too deep set or too small; distended eyelids; too much and too loose skin with too many and too deep folds; too much dewlap; too narrow a head. Dogs which are too big, with bodies too heavy or too massive, are equally undesirable because this impedes their function.
	EYES : Eyes of moderate size, oval, not weeping, neither protruding nor sunk into the socket, leaving the iris totally visible. Lids with no irregularity in their contour, normally fitting around the eye-ball ; lower lids a little slack so that a little haw is visible are nevertheless tolerated. At no time should the eye-lashes touch or interfere with the eyes.

<b>Bassethound (RSI-ras) *</b> 27.01.2011/EN FCI-Standard N° 163 Rasgroep VI	<p><b>IMPORTANT PROPORTIONS: The distance from withers to elbow is equal to the distance from elbow to ground.</b></p> <p><b>HINDQUARTERS:</b> General appearance: <b>In profile the foot is directly under the hip joint.</b> Thigh: <b>Well developed.</b> Stifle (Knee): <b>Only slight bend.</b> Lower thigh: <b>Well developed.</b> Metatarsus (Rear pastern): <b>Hocks well let down..</b> Hind feet: Small, round, cat-like, standing well <b>up</b> on toes.</p> <p><b>GAIT / MOVEMENT:</b> <b>Relatively short striding, hind feet not lifted high, appearing to skim the ground, resulting in pendulum like action when seen in profile. Its distinctive short-striding gait allows it to move freely, never lumbering and with excellent endurance. Dogs should always be able to move freely and soundly without any sign of distress.</b></p> <p><b>COAT:</b> Rough: Profuse, abundant, dense, straight and stand-off <b>but not excessive in length.</b></p> <p>It is important to bear in mind that this is a working hound and must be fit for purpose therefore should be strong, active and capable of great endurance in the field.</p> <p>There may be a <b>small</b> amount of wrinkle at brow and beside eyes. In any event skin of head <b>supple enough as to wrinkle slightly</b> when drawn forward or when head is lowered.</p> <p><b>EARS:</b> Long; reaching <b>only slightly beyond</b> end of muzzle of correct length, but not excessively so.</p> <p><b>UNDERLINE AND BELLY:</b> <b>There should be adequate clearance between the lowest part of the chest and the ground to allow the hound to move freely over all types of terrain.</b></p> <p><b>FOREQUARTERS</b> General appearance: <b>Some wrinkles of skin may appear on lower legs, but this must on no account be excessive.</b></p> <p><b>HINDQUARTERS</b> General appearance: <b>Some wrinkles of skin may appear between hock and foot, and at rear of joint a slight pouch of skin may be present, but on no account should any of these be excessive.</b></p> <p><b>GAIT / MOVEMENT:</b> <b>Most important to ensure that the hound is fit for purpose.</b></p> <p><b>SKIN:</b> <b>Supple and elastic without any exaggeration.</b></p>
<b>Drever *</b> 26.07.2006/EN FCI-Standard N° 130 Rasgroep VI	<p><b>IMPORTANT PROPORTIONS :</b> <b>The distance between ground and sternum should be 40% of the height at the withers. The muzzle should equal the skull in length.</b></p> <p><b>Chest :</b> <b>Well developed, oval and clearly reaching below elbows.</b> Ribs well developed <b>to the rear. Well defined prosternum.</b></p> <p><b>SERIOUS FAULTS :</b> <b>Too low on legs.</b></p> <p><b>DISQUALIFYING FAULTS:</b> <b>Faulty position of one or both canines of the lower jaw which, when the mouth is shut, can damage the upper gums or the palate.</b></p>
<b>English Foxhound *</b> 03.06.2009/EN FCI-Standard N° 159 Rasgroep VI	<p><b>MUZZLE:</b> Long and square. <b>Moderately developed flews.</b></p> <p><b>LOIN:</b> With a <b>slight rise over</b> strong loins.</p> <p><b>STIFLES:</b> <b>Moderate turn.</b></p>

<b>Amerikaanse Cocker Spaniel (RSI-ras) **</b> 22.01.1999/EN FCI-Standard N° 167 Rasgroep VIII	
<b>Clumber Spaniel (RSI-ras) *</b> 12.01.2011/EN FCI-Standard N° 109 Rasgroep VIII	GENERAL APPEARANCE: Balanced, <b>well</b> boned, active with a thoughtful expression, overall appearance denoting strength. <b>The Clumber should be firm, fit and capable of a day's work in the field.</b>
	HEAD: <b>Large</b> , square, medium length. No exaggeration in head and skull. EYES: Clean, dark amber. Full light eyes highly undesirable. <b>Acceptable to have some haw showing but without excess.</b> Free from <b>obvious eye problems.</b> <b>BODY: Long, well muscled and strong.</b> CHEST: Deep; well sprung ribs <b>which are carried well back.</b> HINDQUARTERS: General appearance: Very powerful and well developed <b>hindquarters.</b> <b>Ideal weight: Males: 29,5 – 34 kgs. Females: 25 – 29.5 kgs.</b>
<b>Grote Münsterlander *</b> 05.03.2014/EN FCI-Standard N° 118 Rasgroep VIII	FAULTS: Eye too light. Visible red haw. <b>Loose eyelids. Too short muzzle.</b>
	DISQUALIFYING FAULTS: Entropion, ectropion.
<b>Labrador Retriever *</b> 12.01.2011/EN FCI-Standard N° 122 Rasgroep VIII	GENERAL APPEARANCE: Strongly built, short-coupled, very active; ( <b>which precludes excessive body weight or substance</b> ).
	CHEST: Of good width and depth, with well sprung barrel ribs – <b>this effect not to be produced by carrying excessive weight.</b>
<b>Lagotto Romagnolo (RSI-ras) **</b> 17.12.2015/EN FCI-Standard N° 298 Rasgroep VIII	<b>RSI betreft het gedrag</b>

	LOIN: <b>Well developed and muscular in both width and depth.</b> TAIL: Previously customarily docked <b>to</b> 13-18 cms. Docked: Set low and never carried above level of back. Tail thickly <b>covered</b> with hair but not feathered. Undocked: Set low, of medium length, and not carried above the level of the back. It should taper gradually to a point and be moderately feathered. <b>Lively tail action is typical of the breed.</b>

<b>Chihuahua (RSI-ras) ***</b> 16.09.2010/EN FCI-Standard N° 218 Rasgroep IX	SEVERE FAULTS: Narrow skull • Eyes small, deep set or protruding. • Long muzzle. • Under or overshot mouth. • Unstable stifle.
	DISQUALIFYING FAULTS: Dogs with an open fontanel. Deformed jaws. Subjects weighing less than 500 gr and more than 3 kg.
<b>Chinese Naakthond (RSI-ras) **</b> 16.02.2011/EN FCI-Standard N° 288 Rasgroep IX	
<b>Franse Bulldog *</b> 17.04.2015/EN FCI-Standard N° 101 Rasgroep IX	GENERAL APPEARANCE: <b>No point is exaggerated compared to the others, which could spoil the dog's general harmony, in appearance and in movement.</b>
	IMPORTANT PROPORTIONS: <b>The length of the body – between the point of the shoulder and the point of the buttocks – slightly surpasses the height at the withers. The length of muzzle is about 1/6 of the total length of the head.</b>  FACIAL REGION: <b>The head of the Bulldog is characterized by a shortening of the maxillary-nasal part as well as a slight to moderate slope of the nose backwards. The nose is slightly upturned (“snub nose”).</b> The tongue must never show when the dog is <b>not excited.</b>  The lower jaw <b>projects in front of the upper jaw and turns up. The arch of the lower incisors is rounded. The jaw must not show lateral deviation, or torsion. The gap between the incisors of the upper and the lower jaw should not be strictly delimited, the essential condition being that the upper and the lower lips meet to completely cover the teeth.</b>  TOPLINE: Rising progressively, <b>but not excessively, from the withers towards the loin. That conformation – also called roachback – is typical for the breed.</b>  CHEST: Cylindrical and well let down ( <b>slightly under the elbows</b> ); <b>very well sprung ribs</b> , so-called “barrel shaped”. Fore chest, broad and <b>square-shaped</b> , seen from the front.  TAIL: <b>Naturally short, ideally long enough to cover the anus.</b>  DISQUALIFYING FAULTS: <b>Completely closed nostrils. • Torsion or lateral deviation of the jaw, resulting in the tongue constantly being visible. Taillessness or ingrown tail. Reversed hock.</b>  <b>Respiratory distress. • Deafness.</b>

<p><b>King Charles Spaniel (RSI-ras) *</b> 19.01.2011/EN FCI-Standard N° 128 Rasgroep IX</p>	<p>SKULL: <b>Moderately</b> large in comparison to size.</p>
	<p>EYES: <b>Relatively</b> large and dark. FOREARM: Legs short <b>and</b> straight.</p>
<p><b>Mopshond (RSI-ras) *</b> 16.02.2011/EN FCI-Standard N° 253 Rasgroep IX</p>	<p>GENERAL APPEARANCE: Decidedly square and cobby, it is “multum in parvo” shown in compactness of form, well knit proportions and hardness of muscle, <b>but never to appear low on legs, nor lean and leggy.</b></p>
	<p>HEAD <b>Relatively</b> large and in <b>proportion to body</b>, round, not apple-headed. SKULL: With no indentation.
